



PROSPECT STARS ACADEMY WAIVER, RELEASE OF LIABILITY & TRAINING AGREEMENT – 2026

Assumption of Risk:

Participation in baseball training, private lessons, partner training, conditioning, evaluations, and related activities involves inherent risks. I voluntarily assume all risks associated with my child's participation.

Release of Liability:

I hereby release, waive, and hold harmless Prospect Stars Academy LLC from any and all claims arising from participation, to the fullest extent permitted by Florida law.

Training Fees & Payments:

Private training rate is \$65 per hour. Partner training rate is \$55 per child. All payments are due prior to the training session unless otherwise agreed in writing.

Cancellation Policy (Tiered):

- Cancellations made 24–12 hours before the scheduled session will be charged 50% of the training fee.
- Cancellations made less than 12 hours before the session or no-shows will be charged 100% of the training fee.

Emergency Exception:

In cases of verified emergencies such as medical emergencies, accidents, family emergencies, or pre-existing medical appointments, reasonable documentation may be required. Prospect Stars Academy reserves the right to approve or deny exceptions at its sole discretion.

Scheduling Policy:

All training sessions must be scheduled 1–2 weeks in advance. Availability is limited and subject to coach and facility schedules.

Quarterly Evaluations:

Prospect Stars Academy conducts quarterly evaluations to monitor player development. Evaluations are instructional and do not guarantee team placement or playing time.

Media & Educational Use Release:

I grant permission for Prospect Stars Academy to photograph and record my child for educational, instructional, and developmental purposes, including video review, player analysis, coach feedback, training demonstrations, and for promotional and marketing use, without compensation.

Code of Conduct:

Parents and athletes are expected to maintain respectful behavior at all times. Prospect Stars Academy reserves the right to remove any athlete or parent for inappropriate behavior, without refund.

Coach Cancellation or Emergency:

- In the event the coach must cancel a session due to emergency, illness, appointment, weather, facility issues, or unforeseen circumstances, Prospect Stars Academy will reschedule the session at no additional cost.

As a coach and as an organization, we deeply value the time of each family and also ours. Respect for schedules and commitments allows us to offer quality training and a professional environment for all children.
